Programme Agreement Dated 13 December 2013 (“Programme Agreement”) as amended and restated on 10 October 2017

We refer to the above. Terms defined in the Programme Agreement shall have the same meanings herein.

We hereby give you notice that pursuant to the provisions of Clause 4.1 of the Programme Agreement, we wish to utilise the Programme and hereby request you to arrange for the issuance of the Subordinated Notes to selected investors pursuant to this notice. Please consider our request to utilise the Programme upon the terms and subject to the conditions in the Programme Agreement, as follows:

- (a) Yield to maturity: 4.30% per annum
- (b) The aggregate nominal value of the Subordinated Notes to be issued pursuant to this Notice: RM600,000,000.00;
- (c) Issue Date: 8 March 2022;

- (d) Maturity Date: 8 March 2032;
- (e) Tenure of the Subordinated Notes to be issued: 10 years non-call 5 (Call Date: 8 March 2027);
- (f) Mode of Issue: Private Placement;
- (g) Purpose of utilisation: Working capital and general banking purposes;
- (h) Coupon Rate: 4.30% per annum payable semi-annually
- (i) Prevailing Rating: A1 by RAM Rating Services Berhad

We hereby request you to remit the proceeds arising from the subscription of the Subordinated Notes pursuant to this Notice to Bank Negara Malaysia account no. MY71BNMA1554010068 favouring AmBank (M) Berhad.

We confirm that:

- (1) each of the conditions contained in Clause 4.1 of the Programme Agreement is satisfied as at the date hereof and we know of no reason why it should not be satisfied as at the said Issue Date referred to above and we further confirm that there are no events or circumstances which should be brought to the attention of Lead Arranger, Lead Manager and/or the Facility Agent for the purposes of Clause 4.1 of the Programme Agreement and that there is no revision to the rating of the Subordinated Notes since the date of the last notice;
- (2) the utilisation of the proceeds arising from the subscription of the Subordinated Notes pursuant to this Notice is in compliance with Clause 2.2 of the Programme Agreement;
- (3) the representations and warranties contained in Clause 6 of the Programme Agreement are repeated on the date of this Issue Request and the Issue Date with reference to the facts and circumstances subsisting at the Issue Date (except that the reference to accounts in Clause 6.1 (e) of the Programme Agreement be construed as a reference to our then latest audited available consolidated financial statements);
- (4) no Cancellation Event or Suspension Event mentioned in Clause 10 of the Programme Agreement or no event, with the lapse of time and/or upon the giving of notice and/or the issue of a certificate and/or the fulfilment of the relevant requirement as contemplated under the Programme Agreement being made would constitute a Cancellation Event or Suspension Event, has occurred and is continuing.
